



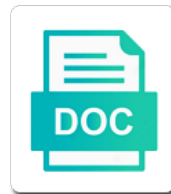
Abate Substantial Tax Understatement Penalty

In February, the IRS published a new Notice, 2018-01, which states that the IRS will not assess a substantial tax understatement penalty if the taxpayer can show that the understatement was primarily or wholly due to a change in the law.
